**Course Description:**

Psychology's primarily empirical perspective sometimes complements the justice system's rule-based nature, and sometimes the two disciplines are at odds. This course focuses on the application of psychological theory, methods, and data to various procedures and issues in the justice system, including eyewitness evidence, the detection of deception, jury decision-making, and the treatment of children and other special groups in the system. Past court decisions and classic conflicts between society's desire for control and individuals' rights and freedoms have provided the impetus for much of the research in the psychology-law area and form the backdrop of the course.

**Course Requirements:**
