The final mark in this course will be based on:

- 1) One 18-20 page paper (55%) [MAJOR PAPER]. This paper will be on the topic chosen by you in class from the list of possible topics provided. The paper is due on November 22nd by 7 p.m. Assignments handed in late will lose 5% per day (including weekend days) unless accompanied by a medical note. Papers over 20 pages long are acceptable but papers under 18 pages are not. Referencing should meet APA style formatting (5th edition).
- 2) One 15-minute in-class paper presentation (15%) You will be responsible for presenting information on the topic that you chose for your paper. Your talk should describe the research conducted in the journal articles listed alongside the topic that you chose.
- 3) One 2-page handout for the class summarizing your in-class presentation (5%). This handout should not be more than two pages and should include the journal articles that you are relying on.
- 4) One 60-minute in-class exam (25%). This exam will include multiple choice, short answer and definition questions based both upon the class readings and lecture materials. The mid-term will be October 25th. Please also see the information on departmental policies regarding missed tests in the UTSC calendar.

4) One 12-15 page paper (25%) [MINOR PAPER]. A writing assignment may be chosen instead of taking the exam. This paper assignment would be in addition to the major paper assignment described above. For those students who would prefer to write this 12-15 page assignment, it will be due on October 25th by 7 p.m. Topics for this paper must be approved by the instructor. Assignments handed in late will lose 5% per day (including weekend days) unless accompanied by a medical note.
