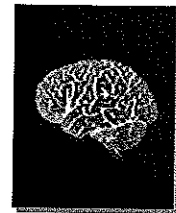

Brief Description

The objective of this course is to survey the discipline of clinical psychology by thoroughly examining topic areas that are of current relevance. Overall, this course employs a seminar-based curriculum. As such, you will find the nature of this course to be unlike many of the courses you have taken to date. Moreover, a seminar is much like the type of learning experience you would gain in either graduate or medical school. Due to the smaller size, there is a greater opportunity for independent learning under the supervision of the instructor.

Since this is a survey course, students are expected to contribute to the curriculum by selecting an appropriate topic to research and write a review paper. Students are also required to present their topic to the class by way of a formal presentation. Areas worthy of consideration include in depth analyses of individual psychological disorders, different treatment modalities, or specific assessment techniques. To this end, students will be able to gain knowledge within a personal area of interest that is germane to this course and disseminate that knowledge to their fellow students.

This course will also incorporate a weekly discussions and thought papers which will concern controversial issues within abnormal psychology. To this end, there is a required textbook (see further on in this syllabus for specific details) from which the most popular issues will be discussed at length in class.

Important Details

Grading Scheme

Attendance & Participation (10%)

Students are expected to learn from each other by way of timely attendance (not arriving beyond 10 minutes after the hour) and participation during student presentations. A signature sheet will be passed around at 10 minutes after the hour to document attendance.

Term Paper Proposal (5%)

Your proposal is due in class as a hard copy on May 25th/26th (depending on your section). Before the next class, each proposal will be reviewed by the instructor to determine (1) whether you determine whether your area of interest is suitable for critical review, (2) you have clearly outlined your research question(s) and, (3) provided evidence of an exhaustive search

of the literature. Two to three content pages (exclusive of title page and references section) formatted according to APA 5th Edition specifications is required for this and all other assignments.

Class Presentation (25%)

Students are required to present a 10-minute review of a current topic within their chosen area of study followed by 5 minutes of questions. The evaluation of your presentation will be based on your demonstrated knowledge of your chosen topic area. This will be assessed by way of the delivery of your presentation, the organization of your material, and your ability to develop and moderate debate within the audience. To this end, you are required to focus your presentation on one or more current issues that will allow for critical thinking within your audience. A strict time-limit of 10 minutes will be enforced so please practice and prepare ahead of time. All of the necessary equipment you will need to conduct your presentation will be provided. Students are expected to design their presentation in Microsoft PowerPoint as this is the software that is available with the provided equipment.

**Note: Students are required to email their presentations to the instructor one day before their presentation date (i.e., before midnight on the evening before class).*

Weekly Thought Papers (20%)

Each week, students are expected to submit a (hard-copy) thought paper (two pages double-spaced in length without the title page or references) on the readings specified for that week. The content of each paper should address one or more of the challenge questions listed at the end of the required reading for that week (i.e., within the textbook). Hard copies must be submitted before the beginning of each class. Those submitted after class has begun will be considered late (10% penalty). As with the weekly thought papers, grading will be based on style, clarity and scholarship. APA style (5th ed.) is also required for this assignment.

Mini Quizzes (10%)

There will be a number of mini pop-quizzes that will occur at the beginning of several classes. The content of these quizzes will pertain to the required readings assigned in the course.

Term Paper (30%)

Students are required to complete a comprehensive review paper. The topic area must be approved by the instructor first. Focus should be either on the evaluation, understanding or treatment of psychological disorder. Other topic areas that are germane to abnormal or clinical psychology will also be considered.

Fifteen to twenty content pages (i.e., excluding title page, abstract, references, etc) are required (no accommodation will be made). As with the weekly thought papers, grading will be based on style, clarity and scholarship. APA style (5th ed.) is also required and will be a component of the grade allocated for this assignment. Please also note that this assignment is due on the last day to submit term assignment in summer courses. For every subsequent day that it is late, 20% will be taken off the total possible grade that could be allocated to this assignment. Lastly, in addition to requirement of submitted a hard copy of your paper, the use of *Turnitin* will be requested (please see the following paragraph). If *Turnitin* is not used, students will be required to submit their rough notes and hard copies of the references that they sourced within their assignments.

Normally, students will be required to submit their course essays to Turnitin.com or a review of textual similarity and detection of possible plagiarism. In doing so, students will allow their essays to be included as source documents in the Turnitin.com reference database, where they will be used solely for the purpose of detecting plagiarism.
