You are required to write all exams. Exams will have **multiple-choice and short-answer questions**. The MCQs are meant to test your knowledge of the material. On top of that, the SAQs are meant to probe your thinking and communication skills. **The final exam will be cumulative in terms of the MCQs and will have some bias for later lectures for the SAQs.** Material on the exams will include lecture material and text readings. Although the topics covered will overlap, different things may be emphasized in class than in the book. Therefore, I recommend listening to the lectures as well as studying the textbook.

Missing 1 mid-term exam: Under exceptional circumstances you may miss the first or the second mid-term exam. In that case, I will re-weight your other mid-term and your final exam (43% and 57%, respectively). However, **I will re-weight only if you provide - within 1 week - valid documentation** for your valid reason to miss the mid-term. To find out what reasons are accepted and what form of documentation is required, please refer to the student calendar or talk to me. One example, if you are sick you will need a medical note (see UTSC webpages for the form). The form needs to be **completed by a medical doctor on the day of the exam** that you are missing plus/minus one day. **A medical note by an acupuncture specialist or a nurse won't be accepted.**

Missing 2 mid-term exams: Though rare, it is not impossible that students miss larger portions of the course including both mid-terms, e.g. due to illness. In that case, you need to provide documentation and also you need to contact me. We'll set up an appointment to discuss how I can help you. There will be a make-up exam covering material from the two mid-terms.

Missing the final exam: If you miss the final exam, you are asked to petition to write the test through the Registrar's office, usually one term later. The format of the final exam might differ from the original final.

Difficulties with the course: *I want you to do well in the course!* Please talk to me if you feel you are having difficulties with the course (or if you have personal issues that might interfere with your performance).
