Goals of the course:

The Imagination Institute of Philadelphia set out to "objectively measure imagination" and derive an "Imagination Quotient." Their mandate to foster innovation encompassed different aspects of imagination including; creativity, prospective thought, counterfactual thinking, mental simulation, and so on, which might prove helpful in academic, health, corporate, or military settings. Such innovation can be facilitated by diverse psychological assets including "curiosity, future-mindedness, openness to experience, optimism, perseverance, perspective, purpose, and wisdom."

The primary goal of this course is to develop an appreciation of the many ways that imagination is revealed in our lives and to learn how to use one's imagination in productive and expressive ways.

Outcomes:

Learning that the boundaries between different subareas of psychology are porous so that imagination, cognition, perception, emotion, and so on are ultimately integrated.

Learning to focus on processes and not on "faculties."

Learning that concepts and operations are constructed by particular scholarly (i.e., discursive) communities and should not be mistaken for phenomena in the world.

Learning to interview people about lived-experiences related to a topic of interest and to infer processes from these interviews.

Learning to build bridges between psychological (i.e., mental) and bodily (i.e., neural) processes.

Learning to build integrative models about imagination that do not reduce people to an Imagination Quotient.

Evaluation:

(1) Midterm test and Final exam, each with 50 multiple choice questions incorporating readings and lecture materials.

(2) Twenty-page term paper worth 1/3 of your grade partly based on interviews related to a topic of interest to you about imagination. The format will be discussed in class.

Your term paper will be due on the last day of the term by midnight in electronic format. Please keep all preliminary notes and materials that you used for the term paper.

(3) 2% will be deducted from the term paper grade for each day that it is late by midnight.

(4) There will also be in class exercises that can lead to *up to 3 bonus points* in the final course grade.

Your final grade is based on: Midterm (1/3), Final Exam (1/3), and Term Paper (1/3). Students must take both exams and complete the term paper in order to receive a grade.

Missed Term Work due to Medical Illness or Other Emergency:

All students citing a documented reason for missed term work must submit their request for accommodations within three (3) business days of the deadline for the missed work.

Students must submit **<u>BOTH</u>** of the following:

- A completed Request for Missed Term Work Accommodations form (<u>http://uoft.me/PSY-MTW</u>), and
- (2.) Appropriate documentation to verify your illness or emergency, as described below.

Appropriate documentation:

For missed **<u>TERM TESTS</u>** due to <u>**ILLNESS**</u>:

- Submit the Request for Missed Term Work Accommodations form (<u>http://uoft.me/PSY-MTW</u>), along with an <u>original</u> copy of the official UTSC Verification of Illness Form (<u>uoft.me/UTSC-Verification-Of-Illness-Form</u>) or an <u>original</u> copy of the record of visitation to a hospital emergency room. Forms are to be completed in full, clearly indicating the start date, anticipated end date, and severity of illness. The physician's registration number and business stamp are required.
- Note: If an end date of "ongoing" is specified, the medical note will be assumed to cover a period of two weeks. If no end date / an "unknown" end date is specified, the note will be assumed to cover a period of three business days (starting from illness start date.)

For missed TERM TESTS due to ACCESSABILITY REASONS:

 Meet with your AccessAbility consultant and have them email Keely (keely.hicks@utoronto.ca) detailing the accommodations required.

For missed **ASSIGNMENTS** due to **ILLNESS**:

Submit the Request for Missed Term Work Accommodations form (<u>http://uoft.me/PSY-MTW</u>), along with a <u>hardcopy</u> of the Self-Declaration of Student Illness Form (<u>uoft.me/PSY-self-declare-form</u>).

For missed ASSIGNMENTS due to ACCESSABILITY REASONS:

- If your desired accommodation is within the scope of your Accommodation Letter (ex. your letter includes "extensions of up to 7 days" and you need 3 days), submit the Request for Missed Term Work Accommodations form (<u>http://uoft.me/PSY-MTW</u>) and attach a copy of your letter. Specify how many days extension you are requesting on the request form.
- If your desired accommodation is **outside the scope** of your Accommodation Letter (ex. your letter includes "extensions of up to 7 days" but you need more time than that) you will need to meet with your **AccessAbility consultant** and have them email Keely (keely.hicks@utoronto.ca) detailing the accommodations required.

For missed term tests or assignments in OTHER CIRCUMSTANCES:

Submit the Request for Missed Term Work Accommodations form (<u>http://uoft.me/PSY-</u><u>MTW</u>), along with:

- In the case of a **death of a family member or friend**, please provide a copy of a death certificate.
- For U of T varsity-level or professional athletic commitments, an email from your coach or varsity administrator should be sent directly to Keely Hicks (keely.hicks@utoronto.ca) well in advance of the missed work, detailing the dates and nature of the commitment.
- For religious accommodations, please email (<u>keely.hicks@utoronto.ca</u>) well in advance of the missed work.
- For circumstances outside of these guidelines, please email Keely (keely.hicks@utoronto.ca) on or before the date of the test / assignment deadline to describe your circumstances and ask what documentation would be appropriate

Documents covering the following situations are NOT acceptable: medical prescriptions, personal travel, weddings/personal/work commitments.

Procedure:

Submit your (1.) <u>request form</u> and (2.) <u>medical/self-declaration</u>/other documents in person <u>WITHIN 3 BUSINESS DAYS</u> of the missed term test or assignment.

<u>Submit to:</u> Keely Hicks, Room SW420B, Monday – Friday, 9 AM – 4 PM. (Slide forms under door if out of office.)

After submitting your documentation, within approximately one to five business days, you will receive a response from your instructor detailing the accommodations to be made (if any).

You are responsible for checking your official U of T email and Quercus course announcements daily, as accommodations may be time-critical.

You should continue to work on your assignments to the best of your ability, as extension accommodations may be as short as one business day, depending on the nature of the illness/emergency.

If an accommodation has been granted but you are unable to meet the conditions of the accommodation (ex. you need a longer extension, or you missed a make-up test), you will need to repeat the missed term work procedure and submit additional forms to request further accommodation. Note that in the case of a missed make-up test, an opportunity to write a second make-up test may not be provided.

Completion of this form does NOT guarantee that accommodations will be made. The course instructor reserves the right to decide what accommodations (if any) will be made. Failure to adhere to any aspect of this policy may result in a denial of your request for accommodation.

Missed Accommodations

If an accommodation is granted but a continued illness/emergency prevents you from meeting the requirements of your accommodation, you must <u>repeat</u> the missed term work procedure to request additional accommodations.

(E.g.) If you miss a make-up midterm, you would need to submit <u>another</u> Request for Missed Term Work Accommodations form. If your original medical note / documentation included the date of the make-up midterm, then only the Request form is required. If the date of the makeup midterm fell outside of the dates indicated on your original medical note/other documentation, then a new medical note/other appropriate documentation must also be submitted.

Importance of Three Business Day window:

If you are unable to submit your documents in-person within the three business day window, you must email Keely (keely.hicks@utoronto.ca) within the three business day window to explain when you will be able to bring your documents in person. Exceptions to the documentation deadline will only be made under exceptional circumstances. Attach scans of your documentation, and be prepared to bring your documents to Keely in-person as soon as you are well. Late documents may not be accepted.

NOTE: Assignments due at end of term

Instructors cannot accept term work any later than five business days after the last day of class. Beyond this date, you would need to file a petition with the Registrar's Office (https://www.utsc.utoronto.ca/registrar/term-work).

NOTE: Final Exams

This policy applies only to missed assignments and term tests. Missed final exams are handled by the Registrar's Office (<u>http://www.utsc.utoronto.ca/registrar/missing-examination</u>).

On tests and exams:

- Using or possessing unauthorized aids;
- Looking at someone else's answers during an exam or test;
- Misrepresenting your identity; and
- When you knew or ought to have known you were doing it.

In academic work:

- Falsifying institutional documents or grades;
- Falsifying or altering any documentation required by the University, including (but not limited to) doctor's notes; and
- When you knew or ought to have known you were doing so.

All suspected cases of academic dishonesty will be investigated following procedures outlined in the Code of Behaviour on Academic Matters. If students have questions or concerns about what constitutes appropriate academic behaviour or appropriate research and citation methods, they are expected to seek out additional information on academic integrity from their instructors or from other institutional resources.

Note:

You may see advertisements for services offering grammar help, essay editing and proofreading. Be very careful. If these services take a draft of your work and significantly change the content and/or language, you may be committing an academic offence (unauthorized assistance) under the *Code of Behaviour on Academic Matters*.

It is much better and safer to take your draft to the Writing Centre as early as you can. They will give you guidance you can trust. Students for whom English is not their first language should go to the English Language Development Centre.

If you decide to use these services in spite of this caution, you <u>must</u> keep a draft of your work and any notes you made before you got help and <u>be prepared to give it to your</u> instructor on request.

TurnItIn

Normally, students will required to submit their course essays to Turnitin.com for a review of textual similarity and detection of possible plagiarism. In doing so, students will allow their essays to be included as source documents in the Turnitin.com reference database, where they will be used solely for the purpose of detecting plagiarism.
