Overview of course content and learning objectives: This course focuses on theory and research in the area of socialization. In the first part of the term, we will examine topics such as the concept of conscience; the development of moral judgment; cultural perspectives; self-regulation and moral action. Classes in the first part of the term are lecture/discussion. The course learning objectives in this first part of the term are to acquire an in-depth understanding of key concepts and research findings representing major theoretical perspectives on the psychology of moral development and to critically analyse their respective strengths and limitations.

In the second part of the term, class members will examine selected issues relevant to socialization processes and social development in the context of seminar presentations. These issues represent topics of ongoing social relevance and debate; for example, the impact of social media on children's development; the impact of day-care on development in the first two years of a child's life. The course learning objectives in this part of the term focus on developing your presentation skills when talking to a seminar group, specifically, the accuracy, clarity and organization of concepts and research findings presented, the ability to develop a line of argument based on empirical evidence from the research literature and being able to respond to constructive questions and comments.

#### **Evaluation**

**Examination**: There will be an in-class term examination (essay format) on October 8. The exam covers material from class lectures and from the required reading during the first part of the term.

**Seminar presentation and paper**: During the second part of the term, there will be individual student seminar presentations concerning salient controversies in the area of social development and socialization. You each will also write a paper on your seminar topic. You will be choosing a seminar presentation topic early in the term from a list provided by Prof. Dion. More information about the format for the seminar presentation and the paper will be provided when the topics are chosen.

**Seminar participation**: In addition to your own seminar presentation and paper, seminar participation (taking part in class discussion throughout the term; asking questions about others' seminar presentations) is another component of this course. More details about the format for seminar participation during the second part of the term will be provided when the topics are chosen.

The weighting of each component of evaluation is as follows:

Examination (in class on October 8): 35%

Seminar presentation: 25%

Paper: 20%

Seminar participation: 20%

**Required Reading**: There is no textbook to purchase. The required reading can be accessed either through the E-reserves quick link on the UTSC Library homepage or from the Library Course Reserves module on the Quercus course page for Psy D22.

### Missed Term Work due to Medical Illness or Other Emergency:

All students citing a documented reason for missed term work must submit their request for accommodations within three (3) business days of the deadline for the missed work.

## Students must submit **BOTH** of the following:

## **Appropriate documentation:**

### For missed **TERM TESTS** due to **ILLNESS**:

- Note: If an end date of "ongoing" is specified, the medical note will be assumed to cover a period of two weeks. If no end date / an "unknown" end date is specified, the note will be assumed to cover a period of three business days (starting from illness start date.)

#### For missed TERM TESTS due to ACCESSABILITY REASONS:

 Meet with your AccessAbility consultant and have them email Keely (keely.hicks@utoronto.ca) detailing the accommodations required.

## For missed **ASSIGNMENTS** due to **ILLNESS**:

• Submit the Request for Missed Term Work Accommodations form (<a href="http://uoft.me/PSY-MTW">http://uoft.me/PSY-MTW</a>), along with a

<u>hardcopy</u> of the Self-Declaration of Student Illness Form (<u>uoft.me/PSY-self-declareform</u>).

#### For missed **ASSIGNMENTS** due to **ACCESSABILITY REASONS**:

- If your desired accommodation is **within the scope** of your Accommodation Letter (ex. your letter includes
  - "extensions of up to 7 days" and you need 3 days), submit the Request for Missed Term Work

- Accommodations form (<a href="http://uoft.me/PSY-MTW">http://uoft.me/PSY-MTW</a>) and attach a copy of your letter. **Specify how many days extension you are requesting** on the request form.
- If your desired accommodation is **outside the scope** of your Accommodation Letter (ex. your letter includes "extensions of up to 7 days" but you need more time than that) you will need to meet with your **AccessAbility consultant** and have them email Keely (keely.hicks@utoronto.ca) detailing the accommodations required.

For missed term tests or assignments in **OTHER CIRCUMSTANCES**:

Submit the Request for Missed Term Work Accommodations form (<a href="http://uoft.me/PSY-MTW">http://uoft.me/PSY-MTW</a>), along with:

- In the case of a **death of a family member or friend**, please provide a copy of a death certificate.
- For U of T varsity-level or professional **athletic commitments**, an email from your coach or varsity administrator should be sent directly to Keely Hicks (<u>keely.hicks@utoronto.ca</u>) **well in advance** of the missed work, detailing the dates and nature of the commitment.
- For **religious accommodations**, please email (<u>keely.hicks@utoronto.ca</u>) **well in advance** of the missed work.
- For circumstances **outside of these guidelines**, please email Keely (<u>keely.hicks@utoronto.ca</u>) on or before the date of the test / assignment deadline to describe your circumstances and ask what documentation would be appropriate

Documents covering the following situations are NOT acceptable: medical prescriptions, personal travel, weddings/personal/work commitments.

## **Procedure:**

Submit your (1.) <u>request form</u> and (2.) <u>medical/self-declaration/other</u> documents in person <u>WITHIN 3 BUSINESS DAYS</u> of the missed term test or assignment.

**Submit to:** Keely Hicks, Room SW420B, Monday – Friday, 9 AM – 4 PM. (Slide forms under door if out of office.)

After submitting your documentation, within approximately one to five business days, you will receive a response from your instructor detailing the accommodations to be made (if any).

You are responsible for checking your official U of T email and Quercus course announcements daily, as accommodations may be time-critical.

You should continue to work on your assignments to the best of your ability, as extension accommodations may be as short as one business day, depending on the nature of the illness/emergency.

If an accommodation has been granted but you are unable to meet the conditions of the accommodation (ex. you need a longer extension, or you missed a make-up test), you will need to repeat the missed term work procedure and submit additional forms to request further accommodation. Note that in the case of a missed make-up test, an opportunity to write a second make-up test may not be provided.

Completion of this form does NOT guarantee that accommodations will be made. The course instructor reserves the right to decide what accommodations (if any) will be made. Failure to adhere to any aspect of this policy may result in a denial of your request for accommodation.

## **Missed Accommodations**

If an accommodation is granted but a continued illness/emergency prevents you from meeting the requirements of your accommodation, you must <u>repeat</u> the missed term work procedure to

request additional accommodations.

(E.g.) If you miss a make-up midterm, you would need to submit <u>another</u> Request for Missed Term Work Accommodations form. If your original medical note / documentation included the date of the make-up midterm, then only the Request form is required. If the date of the make-up midterm fell outside of the dates indicated on your original medical note/other documentation, then a new medical note/other appropriate documentation must also be submitted.

## **Importance of Three Business Day window:**

If you are unable to submit your documents in-person within the three business day window, you must email Keely (keely.hicks@utoronto.ca) within the three business day window to explain when you will be able to bring your documents in person. Exceptions to the documentation deadline will only be made under exceptional circumstances. Attach scans of your documentation, and be prepared to bring your documents to Keely in-person as soon as you are well. Late documents may not be accepted.

### **NOTE:** Assignments due at end of term

Instructors cannot accept term work any later than five business days after the last day of class. Beyond this date, you would need to file a petition with the Registrar's Office (https://www.utsc.utoronto.ca/registrar/term-work).

## **NOTE: Final Exams**
