PSYD33: Current Topics in Clinical Psychology: Psychotic Disorders Fall 2020

Objectives

The objective of PSYD33 is to provide students with an in-depth understanding of research in psychotic disorders such as schizophrenia and schizoaffective disorder. Topics will include symptoms of psychotic disorders, neurocognitive dysfunction and its relationship to community functioning, pharmacological and psychological treatment, and the assessment of symptoms across the lifespan. Emphasis is placed on readings, critical review of original research articles, and conceptualizing directions for future study.

Course Format

The format of this course will be largely focused on class discussion and small group activities, with brief didactic lectures from the professor and guest lecturers. All classes will take place through virtual delivery.

Zoom Etiquette

Although this class is delivered virtually, it is expected that you keep your video on throughout the class unless you have prior approval from Dr. Best. It is important to keep your video on so that the instructor and other students receive visual feedback just like in a normal classroom. Additionally, we will be having several guest speakers join the class throughout the term and it is very challenging for guest speakers to speak to a class with no facial feedback. If you have extenuating circumstances that prevent you from keeping your

video turned on during class, please contact Dr. Best as soon as possible for permission.

In the interest of maintaining structure during class discussion it is expected that you keep your microphone turned off unless you are called on to make a point. Instead of jumping into conversation, please use the "Raise Hand" function in Zoom and wait until the instructor calls on you before speaking. Although it is generally expected that you will raise your hand and then verbally contribute to the discussion, there may be some instances in which it is appropriate to use the chat function. If there is a situation in which using the chat function is required, please make sure you send your comment to the entire class. The instructor will provide a Zoom overview during the first class.

Required Readings

There is no textbook for this class.

You will be assigned required readings and are expected to have read them by the start of the assigned class.

Evaluation

1. Class Presentations

(a) <u>Topic Presentation (30%)</u>

In teams of 5-6 students, prepare a 30-minute presentation. The presentation will be followed by 15 minutes of questions from students and the professor. Each team member should contribute equally to the development and delivery of the presentation.

Students should develop slides and/or other props for their presentation. The professor will provide the possible topic areas and specific articles for review.

Grading will be based on the comprehensiveness (7.5%) and synthesis (7.5%) of the content, clarity of the presentation (5%), ability to pose important new research questions (5%) and ability to answer questions succinctly and accurately (5%).

All students should be prepared to ask questions of their peers, which will contribute to their credit toward class participation.

(b) Examining Original Data from Popular Media Reports (20%)

In groups of approximately five, students will identify a popular press article that cites a scientific report on psychosis.

The team will retrieve the original data article that was cited and discuss in class the degree to which the media representation of the issue is supported by the data in the paper.

These class presentations will be approximately 10-15 minutes with approximately 5 minutes of discussion by the whole class.

Grading will be based on the critique of the article (10%) and a re-interpretation of the findings (10%) based on a more accurate interpretation of the data, each during the oral presentation.

2. Class Participation and Activities (20%)

(a) <u>Discussion of Readings and Class Topic</u>:

Students are expected to read the assigned articles prior to class. Discussion of the articles will be led by the instructor and each student is expected to provide critical comments. Students should be able to contribute to the discussion by speaking about the background and importance of the work, critique the methods chosen, and discuss the implications of the results. (10%)

(b) Participation in class debates and activities

An informal debate and a variety of other class activities will be held during the term. (10%)

3. Writing Assignments (30%)

Three writing assignments (10% each) will be assigned throughout the term. These tasks will require you to <u>briefly</u> (usually one to two pages double spaced) respond to specific questions from the instructor. The writing assignments will be assigned at least two weeks ahead of time.

For missed **TERM TESTS** due to **ACCESSABILITY REASONS**:

For missed **ASSIGNMENTS** due to **ACCESSABILITY REASONS**:

- For circumstances **outside** of these guidelines, please email Keely (<u>keely.hicks@utoronto.ca</u>) on or before the date of the test / assignment deadline to describe your circumstances and determine appropriate documentation.

Documents covering the following situations are NOT acceptable: medical prescriptions, personal travel, weddings, personal/work commitments.

As stated above, your documents must be submitted within three (3) business days of the deadline for the missed work.

After submitting your documentation:

Within approximately one to five business days, you will receive a response from your instructor detailing the accommodations to be made (if any).

You are responsible for checking your official U of T email and Quercus course announcements daily, as accommodations may be time-critical.

You should continue to work on your assignments to the best of your ability, as extension accommodations may be as short as one business day, depending on the nature of the illness/emergency.

If an accommodation has been granted but you are unable to meet the conditions of the accommodation (ex. you need a longer extension, or you missed a make-up test), you will need to repeat the missed term work procedure and submit additional forms to request further accommodation. Note that in the case of a missed make-up test, an opportunity to write a second make-up test may not be provided.

Completion of this form does NOT guarantee that accommodations will be made. The course instructor reserves the right to decide what accommodations (if any) will be made. Failure to adhere to any aspect of this policy may result in a denial of your request for accommodation.

Missed Accommodations

If an accommodation is granted but a continued illness/emergency prevents you from meeting the requirements of your accommodation, you must <u>repeat</u> the missed term work procedure to request additional accommodations.

(E.g.) If you miss a make-up midterm, you would need to submit <u>another</u> Request for Missed Term Work Accommodations form. If your original medical note / documentation included the date of the make-up midterm, then only the Request form is required. If the date of the make-up

midterm fell outside of the dates indicated on your original medical note/other documentation, then a new medical note/other appropriate documentation must also be submitted.

Importance of Three Business Day window:

If you are unable to submit your documents within the three business day window, you must email Keely (keely.hicks@utoronto.ca) within the three business day window to explain the nature of the delay, and when you will be able to provide your documents. Exceptions to the documentation deadline will only be made under exceptional circumstances.

NOTE: Assignments due at end of term

Instructors cannot accept term work any later than five business days after the last day of class. Beyond this date, you would need to file a petition with the Registrar's Office (https://www.utsc.utoronto.ca/registrar/term-work).
